- 4) Any cancellation charges accrued must be paid prior to obtaining a copy of the evaluation report.
- 5) As a courtesy, we make reminder calls, emails, and/or text messages for appointments, one to two days in advance. Please note, if a reminder call or message is not received, the cancellation

policy remains in effect.
